Ladies and gentlemen,

I am glad to put down a few words for this year's Directory that represents a useful publication to point your business ventures in the Slovak Republic in the right direction. Moreover, development of trade and investment cooperation with foreign business partners represents one of the cornerstones of my ministry's activities. Our network of economic diplomats currently operating in 63 countries and their knowledge and expertise is at your disposal together with the EU representations in the rest of the world.

Year ago, at the outset of the pandemic, I wished I would be commenting today on a positive note. Although the global economy starts to witness first signs of its recovery, cautiousness is still the common denominator of every economic forecast. The COVID-19 crisis shocked the world leading to a decline in every macroeconomic indicator – economy growth, consumption, world trade, unemployment or direct investments. But while exposing our vulnerabilities, it has also opened up new possibilities and affected our daily modus operandi.

One would never say that diplomacy, which is fundamentally based on personal contacts and negotiations, can be executed online using web cameras and computers. And yet the opposite was the truth. I am proud that shifting our strategic and daily activities into the online environment didn't hamper the quality of the Slovak diplomacy performance that have proven once again to be highly professional and adaptable. We were able to come up with innovative and effective tools to defend our political and security interests, protect our citizens abroad, support our businesses and promote our cultural values.

Not only diplomacy had to adapt to new circumstances, but also industry, healthcare, education, social systems and many other spheres. Helping to repair the economic and social damage caused by the coronavirus pandemic, the EU have approved an unprecedented recovery plan to lead the way out of the crisis and lay foundations for a modern and sustainable Europe. Simultaneously, the EU started a strategic foresight of its policies making in order to strengthen our resilience. Focal themes of the EU modernization will be green and digital transformation, in which Slovakia has plenty of space to catch up. The adopted European Green Deal and emerging digital agenda represent tools to bolster innovations, technological progress, modern education, connectivity and digital technologies.

Green and digital transformation should be the main driving forces behind economic development of the Slovak Republic in the coming decades. Our country has an excellent prerequisite to be successful in this endeavour. We have been in situation of fundamental economic transformation not so long time ago. As a result of our decision to pave the way along with our European and Trans-Atlantic partners, Slovakia in the last decade became one of the front-runners in terms of economic growth. Moreover, we were one of the favourite destinations for foreign direct investments having become the world leader in car production per capita. In addition to that, Slovakia has always been perceived as a stable country from political, economic and international standpoint.

And now, the COVID-19 crisis has shown us that a new form of transformation is needed again. Modern and innovative economy based on productive and environmental principles has proved to be a necessity to withstand the current global economic, environmental or pandemic challenges.

Hence, modern principles are at the core of a new strategic document, that my ministry in cooperation with the Ministry of Economy is currently finalising. It will reflect the latest economic trends in the green economy, digitalization, science, research and innovation. The document will also include new tools and forms of presentation of economic diplomacy using new innovative ways to promote and support Slovak companies. Its purpose would be also to redesign the current setting of economic diplomacy pushing it towards more synergy, cooperation with other state stakeholders, usage of modern information technologies and adjusting the activities of our economic diplomats towards current national needs and requirements of business entities.

The future geographical network of economic diplomacy would reflect well balanced system between the EU markets, our closest neighbourhood and the perspective third markets. At the same time, our priorities must be based on the complementarity of exports, investments, innovations and development objectives.

It is not a secret that the EU represents our primary trade partner with its export share amounting up to 85%. Since joining the EU in 2004, our entrepreneurs were able to adapt to the European Single Market that helped them to increase production quality, productivity



and implementation of new technologies. Nevertheless, for both sides painful Brexit has made us realise that the common market is not eternal.

In our close neighbourhood, we are going to exploit the trade and investment potential of our Western Balkan and Eastern European partners while providing our transformation assistance and expertise.

At the global level, the new US administration creates a space for overcoming several past trade disputes and strengthening our trade and investment cooperation. Unique trade opportunities are opening up for Slovak exporters in growing Asian markets, especially thanks to important trade agreements concluded at the end of 2020 and the beginning of 2021, notably the EU-Vietnam Free Trade Agreement, the Regional Economic Partnership Agreement (RCEP) and the EU-China Comprehensive Agreement on Investment (CAI). Last but not least, economic diplomacy will seek new business opportunities in the Middle East, Africa and Latin America.

Science, research and innovation start to occupy more prominent place on the agenda of economic diplomacy. We see great potential in streamlining the efforts of the government, private sector and the academic community. We were happy to introduce a new format called "Innovation days" designed to present Slovak unique innovation companies to the foreign ambassadors in our country. At the same time, we are ready to explore possibilities in the space industry and smart cities concept. New chapter on international cooperation in science and innovations needs to be opened with our partners with strong scientific and innovation systems such as USA, South Korea, Japan, Canada or Israel.

The basic precondition for the Slovak exportoriented economy to thrive is the preservation of the highest possible degree of freedom of international trade and respect for equal, fair and agreed rules on the world market. Unfortunately, the current era shows tendencies of protectionism, economic nationalism, egoism and further questioning of multilateralism. We strongly disagree with such distortions of the global environment and want to use momentum of the new leadership elected in the international economic organizations, such as OECD and WTO, to promote the development of an open and transparent multilateral trading system.

Furthermore, pandemic crisis has not only proven the necessity of global cooperation, but also of global solidarity. I am glad that we were able to help our partners to tackle COVID-19 pandemic through our humanitarian assistance and thanks to unique innovative solutions of our companies.

But there are still many goals to be achieved in this matter. Besides fulfilling our target to increase Official Development Assistance to at least 0,33% of GNI, we will engage our businesses into more development aid projects. Slovak companies have limited historical experience with participation in development markets and sustainable projects driven by international financial institutions, and I deem necessary this to be changed. From the business standpoint active engagement in development assistance helps companies to better penetrate new markets and broaden their geographical business portfolio. From the development point of view, the involvement of private sector helps to mobilize more resources, thus make our development activities more sustainable.

Year 2020 will come into history books as a year of pandemic, but I prefer to regard it also as a year of opportunities. History taught us that every crisis enriches us with new ideas, new visions, new trends. While exploring our weaknesses, testing our resilience and disrupting our ties, we were able to come up with inventions that should shift our economies on the new qualitative level. And I am proud, that Slovakia is not alone on this path, as our country is bound to participate in world trade processes.

Hence, with this foreword, I would like to encourage all foreign entrepreneurs and investors not to hesitate and engage in all forms of businesses with their Slovak counterparts, as they have all the necessary preconditions for your cooperation to thrive. The world has a lot to offer to Slovakia, just as Slovakia has a lot to offer to the world.

WORDS BY THE PRESIDENT OF SCCI PRÍHOVOR PREDSEDU SOPK



The year 2020 cannot be compared to any other period in the history of the independent Slovak Republic in terms of its economic and social development. From the perspective of both the economic downturn and its extent. It should also be mentioned that the first symptoms of the declining pace of the economic growth appeared already in 2019, before the outbreak of the current pandemic, which has significantly accelerated this process. On the other hand, this decline is not as strong as expected at the end of the first half of 2020. I am cautious when it comes to the optimistic growth forecasts for 2021. There are several reasons for that. First and foremost, the beginning of the year 2021 is quite different from the first guarter of the last year in that the companies entered it with rather negative expectations, many of them exhausted their reserves and deferred their payments of social insurance contributions, taxes, and loans that they will probably have to pay already in the course of 2021. The overall business and consumer sentiment is extremely low. In general, I expect that the decline will stop, however, the growth will remain at a low level.

We often forget about the microsphere when assessing the economy, or we perceive it only marginally. However, it is the microsphere that creates material and financial resources for normal functioning of the state and for the remediation of its policies in the social and educational fields, as well as in the field of healthcare, infrastructure, defence, or foreign policy. Such awareness has been largely missing in the philosophy of existing state aid to companies. This aid should not be perceived as help to specific companies, but rather as a tool to maintain societywide activities, employment, as well as a path to an effective restart of the economy as a whole. It makes a big difference whether the economy enters the process of recovery and restart weakened and in bad mood, or whether it is ready for changes. The best, yet not only example in this regard is Germany.

From my point of view, the year 2021 is a big question mark; it is a bit like divination from a glass ball, and its forecasting therefore represents considerable risks in terms of its credibility. The key issue from today's perspective is vaccination and its final effect, which conditions all subsequent considerations. The global reduction of investment activities, the fact that the vast majority of the key economies has gone into recession, that China is in fact the only major economy with real economic growth, is a reality which will affect the development in the forthcoming period. From the point of view of Europe, the situation in the European Union and, specifically, in the eurozone, is not good; the economic downturns, mainly in its southern wing, are striking. From January 1, 2021, there is also the long-awaited Brexit phenomenon after the end of the mutual transition period. All this weakens the position of the European Union within the global economy and global relationships as such. The European Union should clearly define its European continental policy in the economic field. It should clearly review its relationships with the Russian Federation, especially with respect to the continuation of the economic sanctions which naturally weaken both sides.

Slovakia entered the year 2021 not in the best condition, although the country's economic downturn in

2020 is lower than predicted last year. However, the social erosion appears to be a very high-risk factor right from the beginning of the year. The high level of dissatisfaction and distrust may largely influence this year's social, political, and economic story. It is disappointing that the government was unable to come to a common position regarding the Recovery Plan not even until the end of the last year and to present it, an expert discussion, as a complex at the level of the European Commission after. The roundtable debates on the individual parts of the Slovak Recovery and Resilience Plan at the stage of the inter-ministerial consultation procedure were disappointing, too, as they were rather limited to the presentation of the particular components of the Recovery Plan by the executive branch. According to the Slovak Chamber of Commerce and Industry (SOPK), all the requirements of the European Commission in the field of the greening of the economy have been implemented in the Recovery Plan which, given the current needs and structure of our economy, are not necessarily a priority. SOPK considers the Recovery and Resilience Fund as a long-term investment loan with the main objective of ensuring the resilience of the Slovak economy in the event of any future crises and to guarantee the competitiveness and sustainability of the development of the public and private sectors in Slovakia. We are of the opinion that the current process of preparation of this plan, especially the non-involvement of the wider professional business community, is a missed opportunity.

I am fully aware of the fact that our internal economic development will be largely dependent on the development of the global economy, especially on the internal development of the European Union's internal market, but in no case should we forget about our own responsibility, about the responsibility of those who manage this country and whose duty is to create a climate of trust in the legal system and not to misuse power. Slovak firms have the capacity to carry this economy through necessary changes, having the managerial and logistic potential, however, this will be overly complicated without the government's support and understanding.

Any war and any change, including the one we are currently experiencing in connection with the fight against the coronavirus, has winners and losers. It depends on the strength and intellect of the individual, company or society which side they join. Those who believe that the world will return to its pre-pandemic state, are lost already now. Those who are able to find their place in the newly created space have a big chance not only to survive, but also to be successful. Let us therefore think also in Slovakia what side we are about to join. I personally see the human dimension, as well as the most part of the social or economic microsphere, to be sound and able to accept changes and develop progressively. The failures we are witnessing today are the consequence of the lack of professionalism and perspective in addressing the present and, simultaneously, in preparing for the future. Because future is not what we are dreaming of today, it is what we are doing today.



Detva



DETVA is situated in the heart of Slovakia, about 220 km from Slovak capital Bratislava. Its area is known

with precious natural and cultural values. Detva is the centre of Podpolanie region, one of the most original Slovak regions, which was named after natural dominant feature of the area – Polana volcano. From 1996 Detva is the centre of the district. Its area is 6,809 hectares and it has about 15,000 inhabitants. Geographical location of Detva in the centre of Slovakia enables good traffic connection with the neighbouring regions as



about roads and railways. The road I/16 (Zvolen – Lučenec – Rožňava Košice) and the R2 expressway with the connection to Detva is the traffic axis of the area. Detva is connected with the railway line Zvolen - Lenártovce - Košice, which runs through southern part of the town. The nearest cargo railway stations are in neighbouring villages Vígľaš and Kriváň. Airport in Sliač is only 27 km from Detva. Good technical and civic infrastructure is available in the town. In the Strategy of Slovak Republic Improvement Detva is one of innovative progress poles. Business and employment support is one of the priorities so that the new business zones are being created. With the EU support of its structural funds (2004 - 2006) Detva town realized reconstruction of some producing parts in PPS factory so that it prepared industrial park for some new investments and for the creation of 538 job positions, mostly in engineering professions. The goal of building of industrial parks and zones for business in Detva and surrounding villages Kriváň and Vígľaš is to provide the opportunities for domestic and foreign companies with work-



ing places in production, service and quaternary sectors, so that for domestic companies' goods and services consumption. The Town of Detva prepared an area for the construction of the Detva – Trstená industrial park. The new production will focus on mechanical engineering and will create over 500 new jobs for the inhabitants of the town and of the region. There is also an area for small and medium-sized enterprises in the proximity of the industrial park. as about the connection with infrastructure but it is capacity limited because of road R2 and also because of limits of protective zones biotopes around Slatina River. They say that the potential of Detva and its surrounding is not used properly. There is a good opportunity not only for visit and getting known of this region but also for investment into business and living in this environmentally pure, clean and beautiful town in the heart of Slovakia.



The Town of Lučenec



The Town of Lučenec is situated in the south of Central Slovakia, close































Air transport

Slovak Chamber of Agriculture and Food (SPPK) represents non-governmental, autonomous and statutory organisation, which was established in line with the Law No. 30/1992 Coll. as amended. The basic role of the Chamber is to enforce the justified common interests of its members, mainly in the process of the agricultural and social policy field. Chamber also takes part in the creation of the state policy concerning the support and protection of its member entrepreneurs to ensure the further development of agricultural production and food processing in the Slovak Republic.

Membership

The members of SPPK are natural and legal entities providing the business activities in agriculture, food industry and in biological, technical and commercial services for agriculture and food processing industry, as well as the other non-governmental organisations operating in the agri-business. The membership in the Chamber is voluntary since January 2005.

Internal organization

Headquarters of SPPK is placed in Bratislava with 15 employees. SPPK also has 38 Regional agricultural and food chambers (RPPK) operating in regions of Slovakia. The "regional" chamber can be established also on the other than just territorial basis. There are also four subjects with the statute of RPPK in accordance to the Statute of SPPK and the Law above. The activities of the Chamber are supervised by the official bodies – the General Assembly, the Board of Directors, the President and the Supervisory board.

Internal Communication

The Chamber is using the wide-spread net of its regional chambers in the whole territory of Slovakia. The central office communicates with the regional chambers using the internet and

emails, but also regular meetings to discuss the actual issues. The Slovak Agricultural and Food Chamber is the only autonomous organisation in the Slovak Republic combining the entrepreneurs operating in agricultural primary production, food processing industry and services for agriculture. SPPK is communicating also to its member associations as well as to the other agricultural autonomous organisations. All the members of SPPK have direct access to the regional office in which they are registered, but also to the central office in Bratislava.

Activities

The Chamber's activities are focused to:

- Lobbying for interests of its members at national and international level
- Legislation legal sector
- · Providing of business information service
- · Guidance and education
- Co operation with the international organizations

Co-operation with national and international partners

The Chamber is cooperating communicating also with the state bodies accordingly to the conditions set out in the Law and in the Agreement on a Co-operation between the Council of the Agricultural Statutory Undertakers and the Ministry of Agriculture of the Slovak Republic to search for the solutions of the problems in agriculture and food sector. SPPK pays extra attention to development of the international contacts and representatives of the SPPK participate at the regular meetings of the representatives of the agricultural chambers from the "Visegrad four" countries (Slovakia, Czech Republic, Hungary and Poland). The representatives of Chamber cooperate also with other agricultural chambers within the European Union.





How do we get on the running train?

The second ending wave of the coronavirus pandemic and the measures and consequences associated with the virus have set up a mirror for us. For us as farmers and food producers, but also for us as societies. Under the influence of the global crisis, we have tried to believe that the political leaders of this state will realize that our inhabitants will not satiate from ordinary phrases about increasing food selfsufficiency. We need an active approach from all those involved - from ordinary farmers and food producers, through sober thinking self-governing organizations to our politicians, to talk once without worries and misleading political marketing which sounds kind to ordinary consumers - a country can feed own nation with home-made food and can also withstand the temporary food shortages on the European market in the event of other global crises.

It is no secret that the agri-food sector is also struggling as a result of coronavirus pandemic. Inputs to food production, inputs affecting plant and animal production, have become significantly more expensive for agricultural and food businesses. Prices of key agricultural commodities on European and world stock exchanges have risen rapidly since the beginning of the year. The market also responds to the current crisis development in the world.

It is no secret that in such a serious situation, Slovak farmers and food producers have not received the well-deserved amount of compensation that the surrounding countries granted to their food producers. For example, secondary food processing companies were excluded from the first covid aid for the food industry.

Nor is it a secret at all that Slovak farmers and food producers will receive one big zero from the Recovery and Resilience Plan. ZERO. The Slovak Republic is so far the only country that does not have agriculture and food in the Recovery Plan. In this context, it is necessary to point out (according to the arguments of the Ministry of Finance of the Slovak Republic) that none of the EU member states had agriculture and food in the recommendations under the European Semester and all countries are part of the EU Common Agricultural Policy.

All submitted recovery plans include agriculture and food. They are different in the allocated volume of resources (0-13%

of the total volume of grants) as well as the content focus. In all Recovery Plans agriculture and food are considered as important parts of the green transition and also a strategic sector for countries' resilience (especially in the light of corona crisis). We can also see, that member states are targeting on identified priorities with specific measures reflecting their specific situation. Among the measures, the resilience and competitiveness of the sector play an important role. In some cases, food sovereignty is explicitly mentioned. Several proposed measures of member countries are consistent with the priorities of the Slovak agri-food sector (competitiveness, sovereignty, storage capacities, irrigation systems, reduction of energy intensity, adaptation of the sector to climate change, land consolidation, restructuring of the slaughterhouse network, etc.).

However, it remains a secret, how under such unequal conditions and with less support for our food producers, we can guarantee in the future that we grow, for example, enough vegetables, fruit, potatoes or keep enough livestock to feed all of us. Phrases about increasing food self-sufficiency under such unequal conditions will remain only phrases.

We also have to tell, that we don't need so much to reach food self-sufficiency. Because to be self-sufficient, for example, in the production of onion, we need to grow it on an area 240 hectares larger than today.

If we plant 300 hectares of fruit trees every year for 5 years, we will increase the food self-sufficiency in fruit production to the desired 100%. Seemingly simple tasks, but ... To solve them, we need to have real experts who use sober reasoning, constructive thinking and courage instead of fiery speeches in front of the media.

This is one of the reasons why Slovak farmers and food producers are well asking if they will be able to jump on a running train crossing through the European food market.


