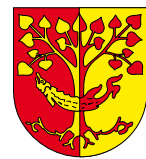

Ladies and gentlemen,

Let me share with you my evaluation how Slovak diplomacy, specifically our economic diplomacy, managed to cope with huge political and economic challenges.

Year ago, I reflected on the pandemic outbreak and the negative effects it had on the Slovak and world economy growth, trade, unemployment or execution of daily activities of our diplomacy. One would hardly believe, that after the unprecedented crisis of COVID-19, we would be dealing with war aggression in our neighbourhood with all accompanied negative implications. The Russian aggression in Ukraine has changed the global economic outlook with sharply rising food, fuel and energy prices. Taken together with the recovery from the pandemic, the surge in inflation and the tightening of monetary policy, the war adds to an already inhospitable economic environment.

The current geopolitical situation has changed the global economic environment, global supply chains and has shown vulnerabilities of our globalized economy. The Russian aggression in Ukraine has also caused countries, including Slovakia, to think about the need for more predictable and reliant trading partners, about the structure of economies and sources of energy. Building a strong economic base and reducing strategic dependence in the most sensitive areas such as critical raw materials, semiconductors, healthcare, food and others is a long-term strategic goal. In the short term, we see building partnerships with like-minded partners as priority steps. No country can be self-sufficient in the modern global world.

At the same time, we need to overcome our traditional approach of building economic growth based on export and investment performance. More importantly, we need to increase our competitiveness and ensure sustainable growth based more on Slovakia's innovation performance and potential. We simply have to realize that the new era requires new answers. Answers that would enable to shift success of the Slovak economy over the last 30 years towards massive development of new technologies, research, innovations and also to reflect new fundamental changes in world trade.

This is also a homework for our economic diplomacy. My ambition is to be more tailor-made, to understand what makes Slovakia competitive, where is demand for our products and services, what is our assignment from the state and non-state stakeholders to be carried out on the foreign markets. Our priorities are to improve cooperation between all domestic stakeholders in the field of external economic relations, to establish more targeted communication with the business community and to modernize tools and services in this regard.

Above-mentioned goals are the core of a new strategic document that my ministry prepared in cooperation with the Ministry of Economy covering the vision for the period 2022- 2030. It comes together with a new governmental body, the Government Council for Competitiveness and Productivity. The Council was

established to connect state and non-state actors and work together on strategic decisions – how to increase productivity of our economy and strengthen domestic and international competitiveness. We also initiated pragmatic platform called Team Slovakia, with regular meetings of key stakeholders. Its core business is to streamline activities and efforts of state actors providing services and support to our businesses in the international field.

At the same time, we want to be more open to small and medium-sized enterprises, focus more on innovations and better grasp plans and problems of our companies in international trade. In this respect, we have launched several new formats of economic events.

Ministry works actively with many innovative companies and research institutions with unique technologies and worldwide ambitions. That is why we continue in a very successful series of events for Heads of Diplomatic Missions accredited to the Slovak Republic - so called "Innovation Days". Once a month we introduce them a successful Slovak innovative company or research institution with strong international potential.

In order to bolster our interaction with entrepreneurs and academic sphere in our regions, we came up with another initiative called "From Regions to the World". The intention is to get to know our SME clients and to present our support to private companies, scientific research entities, educational institutions, cities and municipalities by the state.

Last but not least, we launched a new format "Export Forum", which represents a strategic event on the export policy of Slovakia, with participation of over 250 companies and our economic diplomats from our embassies.

Russian aggression in Ukraine and two years of pandemic showed us fragility of our globally connected world, how quickly and substantively can the economic and social situation change all over the world. For this reason, evaluating and managing risks is a key prerogative to prepare for future shocks.

The Slovak Republic is not an exemption. We need deeper supply diversification across borders, sectors, regions and countries. I hope this could be achieved via creating solid business bonds, reliable trade partnerships, and innovative solutions. Our economy is ready to reach a new level of development also in cooperation with foreign entrepreneurs and investors. I hope this publication will help you navigate through waters of Slovak business environment in order to fulfil all your business endeavours.

Basic information

The Slovak Republic (short form: Slovakia) is a landlocked state in Central Europe. It has a population of over 5,5 million and an area of about 49,000 square kilometres (19,000 sq mi). Slovakia is bordered by the Czech Republic and Austria to the west, Poland to the north, Ukraine to the east, and Hungary to the south. The largest city is the capital, Bratislava, and the second largest is Košice in Eastern Slovakia. Slovakia is a member state of the European Union, NATO, the United Nations, the OECD, and the WTO among others. The official language is Slovak, a member of the Slavic language family.

The Slavs arrived in the territory of present day Slovakia in the 5th and 6th centuries during the migration period. In the course of history, various parts of today's Slovakia belonged to Samo's Empire (the first known political unit of Slavs), Principality of Nitra (as independent polity, as part of Great Moravia, and as part of the Hungarian Kingdom), Great Moravia, Kingdom of Hungary, the Austro-Hungarian Empire or Habsburg Empire, and Czechoslovakia. A separate Slovak state briefly existed during World War II, during which Slovakia was a dependency of Nazi Germany between 1939–1944. In

1945, Slovakia once again became a part of Czechoslovakia. The present-day Slovakia became an independent state on 1 January 1993 after the peaceful dissolution of Czechoslovakia.

The country joined the European Union in 2004 and the Eurozone on 1 January 2009. Slovakia together with Slovenia and Estonia are the only former Communist countries to be part of the European Union, Eurozone, Schengen Area, and NATO simultaneously.

Establishment of the Slovak Republic

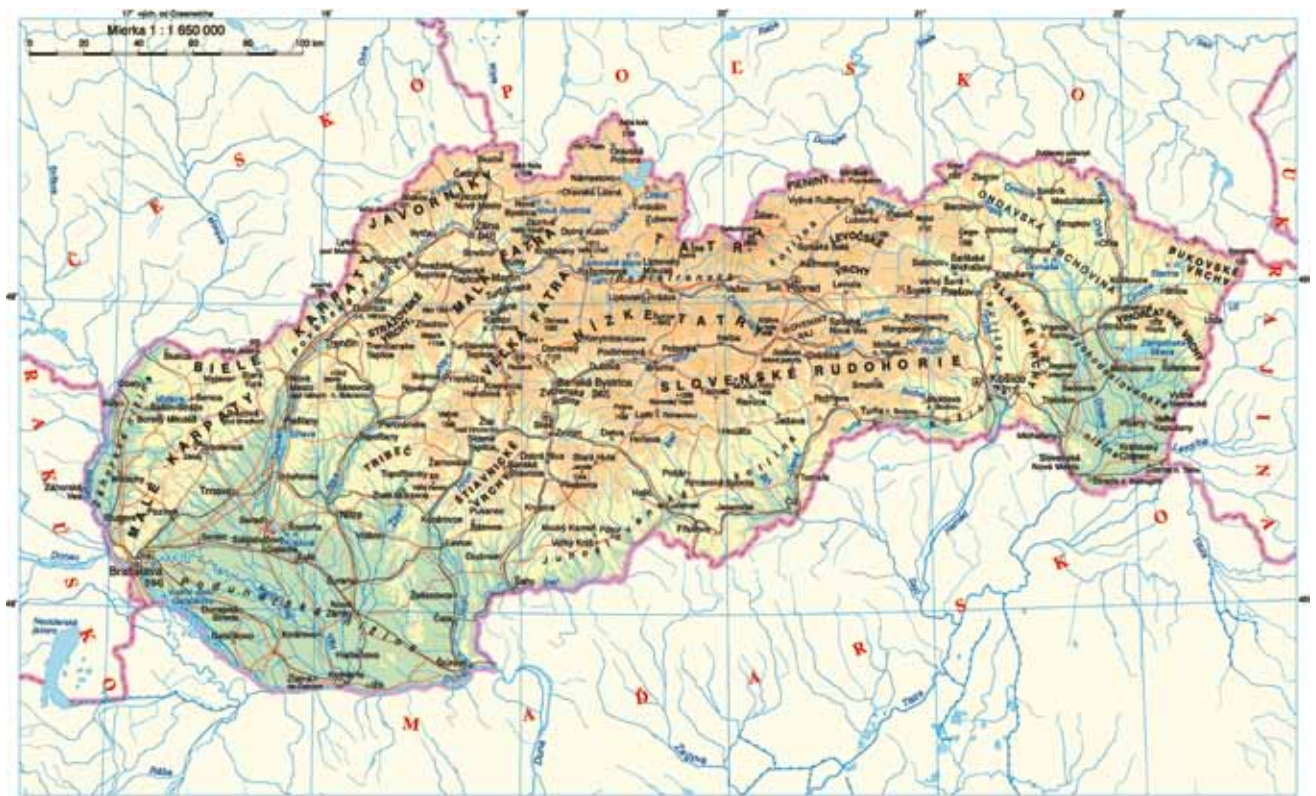
The end of Communist rule in Czechoslovakia in 1989, during the peaceful Velvet Revolution, was followed once again by the country's dissolution, this time into two successor states. In July 1992, Slovakia, led by Prime Minister Vladimír Mečiar, declared itself a sovereign state, meaning that its laws took precedence over those of the federal government. Throughout the autumn of 1992, Mečiar and Czech Prime Minister Václav Klaus negotiated the details for disbanding the federation. In November, the federal parliament voted to dissolve the country officially on 31 December 1992.

The Slovak Republic and the Czech Republic went their separate ways after 1 January 1993, an event sometimes called the Velvet Divorce. Slovakia has remained a close partner with the Czech Republic. Together with Hungary and Poland, the two countries created the Visegrád Group regional platform. Slovakia became a member of NATO on 29 March 2004 and of the European Union on 1 May 2004. On 1 January 2009, Slovakia adopted the Euro as its national currency.

Location and geography

Slovakia lies between latitudes 47° and 50° N, and longitudes 16° and 23° E.

Slovakia is a landlocked country in Central Europe. The Slovak landscape is characterised by great differences. It is noted primarily for its mountainous nature, with the Carpathian Mountains extending across most of the northern half of the country. Amongst these mountain ranges are the high peaks of the Tatra mountains. To the north, close to the Polish border, are the High Tatras which are a popular skiing destination and home to many scenic lakes and valleys as well as the highest point in Slovakia, the Gerlachovský štít at 2,655

metres (8,711 ft), and the country's highly symbolic mountain Kriváň. The largest lowland is the fertile Danubian Lowland in the southwest, followed by the Eastern Slovak Lowland in the southeast. Forests cover 41% of Slovak land surface. Major Slovak rivers are the Danube, the Váh and the Hron. The Tisa marks the Slovak-Hungarian border for only 5 km (3.1 mi).

Climate

Slovakia lies between the mild and continental climatic zone with regular change of four seasons and is characterised by relatively warm summers and cold, cloudy and humid winters. The average temperature is -2°C in winter and + 21°C in summer. January is the coldest month with night temperatures between -10°C and -15°C; the warmest month is July with a daily maximum temperature of approximately +32°C.

Administrative divisions

As for its administrative divisions, Slovakia is subdivided into 8 regions ("kraje"), each of which is named after its principal city. Regions have enjoyed a certain degree of autonomy since 2002. They are referred to as self-governing regions or higher territorial units (abbreviation: VÚC).

1. Bratislava Region (capital Bratislava)
2. Trnava Region (capital Trnava)
3. Trenčín Region (capital Trenčín)
4. Nitra Region (capital Nitra)
5. Žilina Region (capital Žilina)
6. Banská Bystrica Region (capital Banská Bystrica)
7. Prešov Region (capital Prešov)
8. Košice Region (capital Košice)

The regions are subdivided into many districts. Slovakia currently has 79 districts.

Economy

The Slovak economy was considered a developed economy with the attribute "Tatra Tiger". During the post-revolutionary years at the beginning of the 1990s, Slovakia transformed from a centrally planned economy into a market economy. Large-scale privatisation processes were completed, the banking sector is in private hands, and foreign investments increased.

Slovakia was noted for its permanent high economic growth. In 2006, it achieved the highest GDP growth (8.9%) among OECD members. According to Eurostat data, Slovakia's GDP per capita in PPS in 2008 reached 72% of the EU average.

The Slovak economy has moved away from the EU average by 8 percentage points over the last ten years. According to official Eurostat data, Slovakia has been overtaken by all three Baltic countries, neighbouring Hungary, and Poland, and even Romania and Croatia. Within the European Union, Bulgaria has the lowest GDP per inhabitant, followed by Greece and Slovakia as the third poorest country in the EU.

In recent years, Slovakia has fallen relatively sharply in the ranking of EU countries. While in 2011 it was the third strongest economy in the Central and Eastern European region after Slovenia and the Czech Republic, in 2021, it became the second weakest after Bulgaria.

The economic model based on cheap labour and on attracting foreign investments, on which the growth of the economy and the catch-up of the EU at the beginning of this millennium was built, is gradually being exhausted. The state fails to transform its economy into a knowledge-based economy. In a knowledge-based economy, the key role is played by the quality of human capital. And it is precisely investments in the quality of education and the support of innovations in the economic sector that Slovakia has been lagging behind in recent years and decades.

The unemployment rate, which reached its peak of 19.2% at the end of 1999, dropped to 7.51% in October 2008, according to the Slovak Statistical Office. In addition to economic growth, this reduction was due to labour migration to other EU countries. After a slight increase in the period affected by the pandemic, the development of the unemployment rate took a favourable trend, except in some less developed districts. In 2022, the unemployment rate in Slovakia is 7.09%.

Inflation fell from an average annual rate of 12.0% in 2000 to just 3.3% in 2002, which was an election year, but rose again in 2003–2004 due to rising labour costs and excessive taxes. In 2005, it reached 3.7%. After a steadily low inflation rate until 2021, the National Bank of Slovakia expects in its latest forecast that it will grow faster this year and in the next year. Considering a scenario with a relatively moderate development of the conflict in Ukraine, the inflation rate can reach 7.6% this year and 9.7% next year.

Slovakia adopted the euro on 1 January 2009 as the 16th member of the eurozone. The euro in Slovakia was approved by the European Commission on 7 May 2008. The Slovak crown (koruna) was revalued on 28 May 2008 to 30.126 for 1 euro, which also became the euro exchange rate.

In March 2008, the Ministry of Finance announced that the Slovak economy was sufficiently developed to stop receiving aid from the World Bank. Slovakia became an aid provider at the end of 2008.

Slovakia is an attractive country to foreign investors mainly because of low wages, low tax rates, and a qualified labour force. In recent years, Slovakia has promoted a policy of supporting foreign investments. The inflow of FDI increased by more than 600% since 2000 and cumulatively reached a historical maximum of USD 17.3 billion in 2006, or approximately USD 22,000 per capita by the end of 2008.

Despite the sufficient number of researchers and a decent secondary education system, Slovakia, together with other post-communist countries, still faces major challenges in the field of the knowledge economy. Business and public spending on research and development is well below the EU average. The international student assessment programme, coordinated by the OECD, currently ranks Slovak secondary education the 30th in the world (just behind the USA and just before Spain).

The poorly managed pandemic caused significant and, in the tourism sector, even existential problems.

The current energy crisis points to the inability of the current government to solve this, from the point of view of the economy, existential problem. The effects of the massive increase in energy prices are felt by everyone, and without the immediate implementation of systemic measures, the following months will be disastrous. Mass layoffs, production cuts, and business closures are becoming a reality in Slovakia.

At the same time, ill-advised “privatisation” and the inability to buy back energy companies has been revealed for all to see.

Industry

Although Slovakia's GDP comes mainly from the tertiary (services) sector, the industrial sector also plays an important role within its economy. The main industry sectors are car manufacturing and electrical engineering. Since 2007, Slovakia has been the world's largest producer of cars per capita, with a total of 571,071 cars manufactured in the country in 2007 alone. There are currently three automobile assembly plants: Volkswagen's in Bratislava, PSA Peugeot Citroen's in Trnava, Kia Motors' Žilina Plant, and Land Rover near Nitra. In 2022, Volvo will also start building its plant in eastern Slovakia.

Bratislava's geographical position in Central Europe has long made Bratislava a crossroads for international trade traffic. Various ancient trade routes, such as the Amber Road and the Danube waterway, have crossed territory of present-day Bratislava. Today, Bratislava is the road, railway, waterway, and airway hub.

Transportation

Traffic

Bratislava is a large international motorway junction: The D1 motorway connects Bratislava to Trnava, Nitra, Trenčín, Žilina and beyond, while the D2 motorway, going in the north-south direction, connects it to Prague, Brno, and Budapest in the north-south direction. The D4 motorway (Bratislava's outer bypass) is smoothly connected to the A6 Austrian motorway.

Air Transport

Bratislava's M. R. Štefánik Airport is the main international airport in Slovakia. It is located 9 kilometres (5.59 mi) northeast of the city centre. It serves civil and governmental, scheduled, and unscheduled domestic and international flights. The current runways support the landing of all common types of aircraft currently used. The airport has enjoyed rapidly growing passenger traffic in recent years. Smaller airports served by passenger airlines include those in Košice and Poprad.



Ship transportation

The Port of Bratislava is one of the two international river ports in Slovakia. The port connects Bratislava to



international boat traffic, especially the interconnection from the North Sea to the Black Sea via the Rhine-Main-Danube Canal. In addition, tourist lines operate from Bratislava's passenger port, including routes to Devin, Vienna, and elsewhere.

Rail transport

Railways of the Slovak Republic (ŽSR) is a state-owned enterprise managing the state-owned railway infrastructure (including railway transport until 2001) in Slovakia.

According to the law, ŽSR is the railway operator on Slovakia's territory, having the obligation to provide and service national and regional railways and to organise transport on these railways for

all transport operators in accordance with the state's transport policy, without any discriminatory restrictions.

As of December 31, 2021, ŽSR managed 3,626 kilometres of tracks, i.e. 6,820 km of rails. It also manages 8,243 switches, 2,071 crossings, 2,326 bridges with a total length of 52,244 metres, and 76 tunnels with a total length of 45,007 metres. They also own 4,802 buildings. There were 1,585 kilometres of electrified tracks and 1,022 transport lines within the ŽSR network, including 293 railway stations and 22 border stations.

Tourism in Slovakia

Slovakia – A country of tourism

Although Slovakia is small in area, it offers rich tourist attractions.

In terms of its location and the diversity of tourist attractions, Slovakia can be compared to Switzerland and Austria. Slovakia features natural landscapes, mountains, caves, medieval castles and towns, folk architecture, spas, and ski resorts. More than 1.6 million people visited Slovakia in 2006, and the most attractive destinations are the capital of Bratislava and the High Tatras.

Karst areas and caves, water areas

The vast karst areas form a unique whole. The total size of the karst area is approximately 3,000 km², however, only 20 out of 7,500 are open to public. Slovakia is noted for the fact that all three types of caves can be found within its territory: stalactite (dripstone) caves,

ice caves, and aragonite caves. The aragonite cave in Slovakia is one of the three in the world.

Slovakia also offers many water areas suitable for yachting, surfing, and other water sports. There is a total of over 200 tourism centres in Slovakia with large bodies of water.

Healing mineral springs and healing spas

A number of spas of international importance on the basis of healing mineral waters can be found in Slovakia, in which diseases of the locomotor system, digestive tract, and post-operative conditions are treated. The best known spas include Piešťany, Trenčianske Teplice, Dudince, and Bardejov. The climatic spa for the treatment of the respiratory system diseases in the High Tatras – Štrbské Pleso and Nový Smokovec Spa, or caves for the treatment of allergic diseases of the respiratory tract, suitable mainly for children (Bystrá cave), should also be mentioned.

Thanks to the large number of thermal water springs, recreational resorts offering the possibility to spend a vacation are being constructed in southern Slovakia.

When it comes to water, there are more than 1,300 mineral water springs in Slovakia, which are suitable for drinking and are also used for medicinal purposes.

Folk architecture and folklore

Slovak regions offer a number of folk architecture museums, which show the history of Slovakia in architecture and folklore. Well preserved are the Slovak open-air museums in Jahodníky near Martin, Zverovka in Orava Region, and Pribylina in Liptov Region.

Castles and chateaux

Numerous castles and chateaux testify the ancient settlement of our territory, as well as its importance in terms of location, the most interesting being the Devín Castle, the Bratislava Castle, the Trenčín Castle, the Spiš Castle, the Orava Castle, the Chateaux of Bojnice, and the Zvolen Castle.

Sacral monuments

The sacral monuments throughout Slovakia are genuine pearls of culture, with numerous exhibits of incalculable value, such as the altar of Master Paul in Levoča, which was exhibited at the EXPO in Montreal. The cathedral complexes in Trnava and Nitra should also be mentioned, as well as many preserved and restored synagogues.

The peculiar, highly valuable wooden churches and chapels of the Orthodox, Catholic, and Evangelical Churches in Slovakia, are unique, featuring architecture that naturally harmonises with the landscape. Some of them are built without the use of metal fasteners.

Souvenirs

Typical souvenirs from Slovakia include dolls dressed in folk costumes, ceramic objects, crystal glass, carved wooden figures, črpáks (wooden pitchers), fujaras (a folk instrument inscribed on the UNESCO list), valaškas (a decorated folk hatchet), and above all products made from corn husks and wire, notably human figures.

Souvenirs can be bought in the shops run by the state organisation ÚĽUV (Ústredie ľudovej umeleckej výroby – Center of Folk Art Production). Dielo shop chain sells works of Slovak artists and craftsmen. These shops are mostly found in towns and cities. Prices of imported products are generally the same as in the neighbouring countries, whereas prices of local products and services, especially food, are usually lower.

Slovakia's strategic location

Looking at the map of Europe, Slovakia's strategic location is obvious at first glance. It is a natural crossroads in West-East direction as well as in North-South direction. Slovakia is easily accessible, as the network of Western European motorways extends through Austria up to Bratislava. The Bratislava – Prague motorway connection is also very useful. When arriving by plane, visitors can make use of the airport in Bratislava, Vienna, or Budapest.

Thanks to its location, Slovakia offers ideal opportunities for combining visits to Slovakia with visits to its neighbouring countries, thus allowing for getting to know the entire Central European region.

In 2019, an increased number of tourists found their way back to Slovakia, as confirmed by the latest visitor statistics. According to them, a total of 6,432,934 people visited Slovakia, which represented a 15% increase compared to 2018. These figures also show that tourism in Slovakia was experiencing its best times, with increasing numbers of both domestic and foreign tourists. Slovakia as a tourist destination is traditionally sought for mainly by tourists from neighbouring countries. Most visitors have long come from the Czech Republic, Poland, Germany, and Hungary. Nevertheless, the year 2021 brought different results. The situation related to the Covid-19 pandemic caused the number of visitors to drop to 2.7 million, of which 79% were domestic visitors and 21% from abroad.

Science

- Several Slovaks have made notable technical contributions:
- Jozef Murgaš contributed to development of wireless telegraphy;
- Ján Bahýľ constructed the first motor-driven helicopter (four years before Bréguet and Cornu);
- Štefan Banič constructed the first actively used parachute;
- Aurel Stodola created a bionic arm in 1916 and pioneered steam and gas turbines.
- John Dopyera constructed a resonator guitar, an important contribution to the development of acoustic string instrument.
- American astronaut Eugene Cernan (Čerňan), the last man to visit the Moon, has Slovak heritage.
- Ivan Bella was the first Slovak citizen in space, having participated in a 9-day joint Russian-French-Slovak mission on the space station Mir in 1999.
- Nobel Prize winners Daniel Gajdusek and David Politzer have Slovak ancestors.

Demographics

According to the 2021 census, the majority of the inhabitants of Slovakia are Slovaks (83.82%). Hungarians are the largest ethnic minority (7.75%).

Other ethnic groups include Roma (1.23%),[135] Czechs (0.53%), Rusyns (0.44%) and others or unspecified (6.1%). [136]

Languages

The official language is Slovak, a member of the Slavic language family. Hungarian is widely spoken in the southern regions, and Rusyn is used in some parts of the Northeast. Minority languages hold co-official status in the municipalities in which the size of the minority population meets the legal threshold of 15% in two consecutive censuses.

Religion

The Slovak constitution guarantees freedom of religion. In 2021, 55.8% of population identified themselves as Roman Catholics, 5.3% as Lutherans, 1.6% as Calvinists, 4% as Greek Catholics, 0.9% as Orthodox, 23.8% identified themselves as atheists or non-religious, and 6.5% did not answer the question about their belief.[142] In 2004, about one third of the church members regularly attended church services.

Slovak cuisine

Pork, beef, and poultry are the main meats consumed in Slovakia, with pork being substantially the most popular. Chicken is the most widely eaten poultry, followed by duck, goose, and turkey. A blood sausage called jaternice, made from any and all parts of a butchered pig, also has its fans. Game, especially boar, rabbit, and venison, are generally available throughout the year. Lamb and goat are eaten but are not widely popular.

Wine is enjoyed throughout Slovakia. Slovak wine comes predominantly from the southern areas along the Danube and its tributaries; the northern half of the country is too cold and mountainous to grow grapevines. Traditionally, white wine was more popular than red or rosé (except in some regions), and sweet wine more popular than dry, but in recent years tastes seem to be changing. Beer (mainly of the Pilsner style, though dark lagers are also consumed) is also popular throughout the country.

The town has also achieved admirable results in the field of energy and environment. As one of four towns in Slovakia, it supplies heat to almost all prefabricated households using geothermal energy. Directly on the local housing estate, about ten litres of groundwater with a temperature of more than 90 degrees spring every second from a 2,5-kilometre well. Thanks to the geothermal well, residents have some of the lowest heat prices in Slovakia. There is no need to travel to distant countries for beautiful holiday experiences. Veľký Meder, a modern town with attractions, treasures and visions, is the best proof.

Hlohovec is a district town in the Trnava region. What makes it unique, is its

location on the river Váh, its history and the beer brewing and wine making traditions. For centuries the city has been linked with its landmark – the Hlohovec castle – which was originally a medieval castle from the 13th century. Following a partial restoration, the castle was reopened to the public in the autumn of 2018. Schwechat airport is the main international airport of Austria and is only 50 km distant from Bratislava. There is also regular train and bus connection between Bratislava and Schwechat. Another large international airport accessible is Budapest airport, main airport of Hungary, distant 250 km from Bratislava. It is also possible to use airport Ruzyne in Prague that has regular flights to M. R. Štefánik airport in Bratislava.

Geologists from Comenius University leading by Michal Šujan from Faculty of Natural Sciences discovered, that during the Tertiary Period Mlynská dolina in Bratislava was covered by a large lake. It was inhabited by bivalve molluscs, Ostracods and other animals typical for the brackish waters of sea coasts, with an inflow of fresh water from streams. The inland sea which the scientists named Lake Pannon had brackish water similar to the present-day Caspian Sea. It reached its maximum extent more than 10.6 million years ago, stretching from Vienna to Belgrade and Transylvania in Romania. Lake Pannon was later filled by Danube sediments and receded south towards Serbia, where it disappeared 4 million years ago.



Our students at Youth embassy

On 17 June, 2022, the 12th annual edition of the Youth Embassy project took place in Bratislava. The competition was open to secondary school and university students who presented and implemented their projects. University students were expected to tackle the topic of „Improving the economic situation in the economy and healthcare with emphasis on tourism in Slovakia“. Dominik Kadubiak from the Medical Faculty won the first place and was presented the Palm-tree award. His project was named „Diseases of civilization and reduced performance of active people due to polluted air“. It presented a special respirator designed for athletes who train in cities. The respirator captures harmful particles in the air.



TEDx

The third year of TEDxComenius University was given the symbolic name Renewal. After the pause, life at the university resumed. This year unique TED event, TEDxUniverzitaKomenskéhoLive, introduced ten speakers on Friday, 29 April, 2022, six of them spoke live and four spoke online from at the main TED2022 event. It took place at Unik Mlyny, which was reopened after reconstruction. The event hosted 100 participants. 5 speakers demonstrated ideas worth spreading. In addition, after the online pandemic revolution, the TEDxLive format brought the possibility to participate in events online.



ESET Science Award

For the third year, ESET Foundation has given awards to outstanding personalities of Slovak science for their scientific, research and teaching work. The evening gala took place on 16 October 2021 and was broadcast live on RTVS. An international jury chaired by the Physics Nobel Prize laureate Kip S. Thorne, decided to award the Prize of the Public to associate professor Katarína Mikušová from the Faculty of Natural Sciences.



Slovak emergency lung ventilator in Kenya

The Q-vent mini respiratory support device developed by Slovak scientists is currently helping in Kenya. The device arrived there as part of a humanitarian mission supported by SlovakAid - Slovak Agency for International Development Cooperation. The Q-vent mini was developed at the beginning of the Coronavirus crisis in 2020 by the twin brothers Daniel and Samuel Furka from the Department of Physical and Theoretical Chemistry of the Faculty of Natural Sciences of Comenius University, as well as doctor Patrik Palacka from the National Cancer Institute. They responded to the increased need for lung ventilators and printed the device completely on a 3D printer. The total cost of its production was around €250, which is about 100 times less than the conventional fan costs. Moreover, countries such as the USA, Czech Republic, Portugal, Kenya, India, as well as Brazil and Australia have already shown interest in the Q-vent mini.



Scientist of the year

The most outstanding people of Slovak science received awards at the Scientist of the Year event. The main award, Scientist of the Year 2021, was given to behavioral ecologist Pavol Prokop from the Faculty of Natural Sciences of Comenius University. The 25th year of the event took place on 14 June 2022, in the Moyzes Hall of the Faculty of Arts of Comenius University. Pavol Prokop received the award for clarifying how reproductive strategies and evolutionary aspects of behavioral strategies are involved in avoiding pathogen contamination. He has published more than 170 research papers which are available in the Web of Science (WoS) and Nature Index databases. In 2020 and 2021 his publishing activity generated 961 SCI references.



Future Students and Tourists - Information Centre Welcomes All

Comenius University Bratislava opened a new information and event centre. The Information Centre at 9 Štúrova street is close to the main building of Comenius University at Šafárikovo námestie in central Bratislava. It serves current and future students as well as the general public. The information centre is intended to be the first point of contact for those who are interested in studying at the university. It also hosts various events, trainings, lectures, exhibitions, seminars or art events. Gifts and promotional items of the university are available for purchase and visitors can obtain information about the study and the university.

The centre was created as part of CU's effort to engage with the public more openly and to communicate with current and potential students more effectively. It also aims to increase the involvement of the professional public in the life of the university.

The university transformed what used to be a commercial property into an accessible space. It includes an entrance zone, where visitors can obtain information about studying at the university. The rest of the centre consists of an area which will serve as a cafe during the day and can be converted to an event space as needed.



The Slovak University of Technology in Bratislava provides university education in engineering disciplines. Our education system is based on scientific research, as well as on artistic, engineering and other creative activities. Our faculties, departments, institutes and experts cooperate directly with industrial companies and social organisations, actively taking part in the international cooperation.

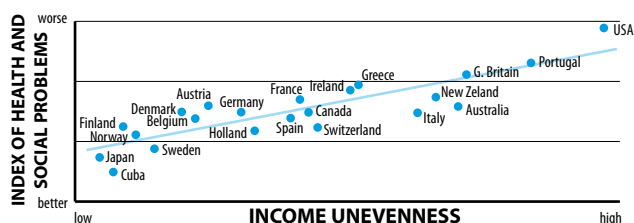
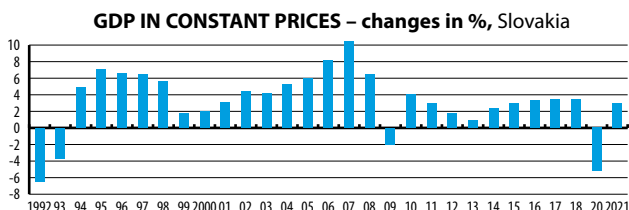

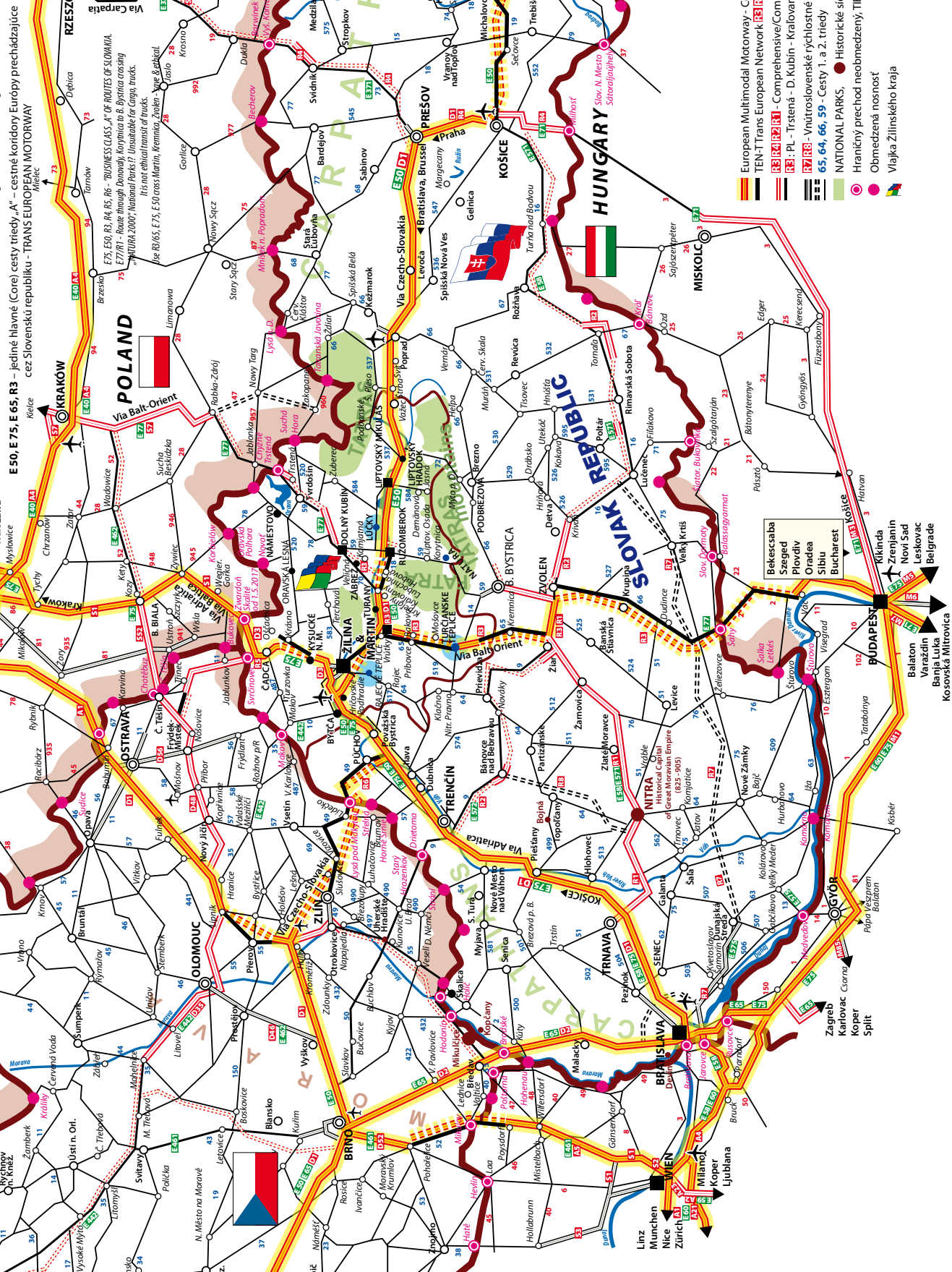

We usually don't think if we can buy enough food in our stores tomorrow. But we do not live standard life for months. We have paid attention when shopping in stores, we talk about prices and we put a little less food in the basket, which – let's be honest – a few months ago, many of us might not even have consumed.

These thoughts of mine will perhaps turn into thinking of all of us, our politicians included, towards the strengthening of our own food safety and food self-sufficiency, which right now take on a completely different meaning and message.

Today there is nothing more important than to ensure stability of food production also in the time of energy crisis, global consequences of war in Ukraine, and historical drought which ruins our country and water sources.

Slovak Chamber of Agriculture and Food (SPPK) represents non-governmental, autonomous and statutory organisation, which was established in line with the Law No. 30/1992 Coll. as amended. The basic role of the Chamber is to enforce the justified common interests of its members, mainly in the process of the agricultural and social policy field. Chamber also takes part in the creation of the state policy concerning the support and protection of its member entrepreneurs to ensure the further development of agricultural production and food processing in the Slovak Republic.

Membership

The members of SPPK are natural and legal entities providing the business activities in agriculture, food industry and in biological, technical and commercial services for agriculture and food processing industry, as well as the other non-governmental organisations operating in the agri-business. The membership in the Chamber is voluntary since January 2005.

Internal organization

Headquarters of SPPK is placed in Bratislava with 15 employees. SPPK also has 38 Regional agricultural and food chambers (RPPK) operating in regions of Slovakia.
